

CVA Muzzleloader Contest Rules

ENTRY: No purchase necessary to enter or win. This contest is open only to natural persons (i.e., not corporate or business entities) who, at the time of entry, are legal residents of the United States, and who are 18 years of age or older at the time of entry.

Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Contest Rules. All entries submitted are final and become the property of Blackpowder Products, Inc.. All entrants will be asked to provide an email address for prize notification.
